### Message from the General Manager

Kia Ora Koutou,

As 2024 comes to a close I would like to thank each and every one of you for the contribution you have made to the Pan Pac operations this year. It has been a particularly tough year while we recommissioned our sawmill and pulpmill, our staff and contractors have stood strong alongside us to ensure we protect each other from harm and enhance our environmental performance.

We recently passed our Forest Stewardship Council<sup>®</sup> (FSC<sup>®</sup>) audit, following four days of scrutiny from two auditors.

FSC<sup>®</sup> Certification is a system that provides a guarantee that forest products come from responsibly managed sources. Pan Pac is proud to have achieved Forest Stewardship Council<sup>®</sup> (FSCIC017103) Certification in December 2001 and maintaining it ever since.

Following their field visits and engagement with our people in the forest and other stakeholders, the auditors were very complimentary about our operations. I genuinely believe that meeting FSC Principles and Criteria in our operations is just part of how we do business every day.

Health & Safety management systems are a critical part of protecting our people from harm. We have them and we expect our contractors to have them, these should be working documents, covering commitment to policy, hazard & risk management, training, event & emergency management and subcontractor management. Over the past 12 months we have been auditing our contractor management systems and this will continue over the next twelve months. The audits are an opportunity to share, learn and improve how we collectively manage safety, health and overlapping duties. Mostly the results of the audits have been positive with only a number of follow-ups required.

To support our health, safety and environmental management systems, Pan Pac has a contractors document page that contains all key documents associated with our operations and expectations, I would encourage you to visit the page and review the documents available, especially our Forest Operations Manual and Environmental standards. As we move towards the Christmas shut down and new year restart, I would ask you to take extra care of yourself and your work mates. Check in with each other each day at your tailgate meetings and during the day, take five by stopping and pausing before completing tasks to ensure you can do so safely and if you can't, stop operations and discuss with your Forman, Employer or Pan Pac Co-ordinator.

Finally, I would like to wish you and your families a very Merry Christmas and Happy New Year.















- Plan, Prepare, Protect

#### Log Bridge in Kaweka – Protecting streams when we can't' get full suspension

Off the back of their excellent job harvesting around the Wetland in Kaweka, DGL Crew 79, alongside harvest supervisor Nick Jones have done some more great work protecting a stream further down the harvest unit. Under the NES- CF, we need to achieve full suspension when harvesting across streams with a bankfull channel over 3m wide. "Bankfull channel" means the width of the stream channel when it's in an annual flood level, so this can often be quite a small stream. Full suspension wasn't achievable in this setting, so we had to apply for a resource consent. As part of this, we committed to shovel logging trees into three lines, minimizing the amount of crossing points over the stream.



Like many waterways in the back of Kaweka, this stream has a high ecological value with cool clear water, and a clean gravel / stoney bottom. Going over and above the minimum, the team were able to shovel all of the felled trees into one line, and formed a log bridge to drag logs across under the carriage. These efforts significantly reduced the potential disturbance to the stream banks and bottom, streamside vegetation, and resulted in much less sediment and slash entering the stream. What small amount of slash that did enter the stream was localized and easily cleaned out. When we presented videos and pictures of this to HBRC as part of our consent conditions they were very impressed.

Another top effort from 79, and more kudos to Nick Jones.

#### Sharp eyes and quick thinking rewarded

Tony and Ben from DGL 75 were given Mitre 10 Vouchers for their efforts protecting a falcon nest in the Wairoa Bridge block. They found a nesting falcon on the boundary of the windthrow in setting 15 at the junction of Rita and Purvis roa. Tony and Ben reported this immediately and left the area and later inspection confirmed that it has a nest under some windthrown trees. A sign was put on the Purvis road bank to stay out of the area. Nice one lads!

### Operations

#### <u>Completed</u>

Harvesting in Elands continued through winter and spring, with the final loads out in November, concluding Pan Pac's 5-year program in the forest.



#### <u>Started</u>

- PHL is back underway with DGL crew 79. Work on the Waikonini Stream crossing, related resource consents and the Flag Range Road entranceway construction tender are ongoing.
- DGL crew 63 have also started in the Wyn-Harris woodlot on Hinerangi Rd, Hatuma. This is expected to take around six to seven weeks to complete.
- DGL crew 73 have moved from Elands to Waipari Station (pic below), Omakere. The 'Bumbles' block is expected to take around four and a half months to complete.



Morrins has also been resumed by DGL crew 75, and is set to be completed in the new year.

#### Upcoming Work

- We have now secured a harvesting agreement for the first 49ha of Yeatman Forest, which will commence before Christmas.
- Harvesting will be resumed in HBRC's Tutira forest prior to Christmas by ATS crew 31, with the aim of completing the Lakeside block.
  - Road construction is set to begin shortly in the Livesey woodlot, preparing for a mid-January start to harvesting.



#### **Market Conditions**

 After enduring subdued export market conditions through winter, prices have slowly but steadily improved through October and November. The expectation is that log prices will remain stable into the early new year, helping to support the planned harvesting levels for summer.

DGL crews 79 and 68 were tasked with the harvesting of this block and we are very pleased to say that two crews took these this responsibility very seriously. The finished job is excellent and shows what passionate people in the industry can achieve with a positive can do attitude and a great sense of ownership and pride in their work.

Thanks to Haze and Rowan and your crews for doing a top job and showing great leadership.

Wetlands are going to be a big part our commitment to keeping the environment safe from harm in the future. Please get hold of one the Pan Pac staff if you need advice or

While continuing with the usual spate of engineering operations (landings, road restore etc) this year has also been a continuation of storm damage repairs from the devastation of Cyclone Gabrielle. The major theme of the repairs has been lasting resilience, manifested in the sizing and armouring of various rebuilt structures.



Anaura Bridge 2. The second bridge along Anaura Rd to replace a C.G. damaged culvert has been a resounding success, the bridge will also accommodate transporters as it is rated to 95T. In the periphery of the bridge, the hydroseeded slopes are noticeably green highlighting the success of the hydroseeding operation. The hydroseeding provides a fast growing vegetation cover to the slopes mitigating risk of erosion.

The Dutch Creek bridge abutment reinstatement is due to take place straight away in 2025 with pier prep work beginning in the lead up to Christmas. Our principal contractor MWL is undertaking this with the assistance of subcontractors SCL. Essentially the method is that pre-cast concrete panels (produced by Lattey and the largest being 8m x 3.3m x 0.15m 10 Ton) will be walked down, sat upon an "elephants foot" (concrete pads in combination with concrete cast in-situ), and then bolted to the piers. It will be backfilled and then armoured with limestone boulders from Gardiner Quarry, Tangoio.



The Tin Hut box culvert was a replacement for a C.G. damaged culvert. This is interesting as it is designed to overtop in a 2 year flood event hence much thought was given to the fashion in which it was armoured and a concrete deck was added to a point higher than 50 year flood levels. Flaxes and hand thrown grass seeded were then planted on the slopes to stabilise them and have flourished even in a seemingly rocky, low-organic base. This job cannot be mentioned without acknowledging the expertise of Quentin "Q" from SCL, this culvert won SCL an award at the Civil Contractors New Zealand Hawkes Bay gala.

The work continues into the new year with remaining storm damage works of a lower priority, business-as-usual operations, and a concentrated woodlots schedule.
